In 2016 Esperanza International provided 6,872 loans to deserving entrepreneurs in the Dominican Republic through its microfinance programs. Of those loans, 88% were disbursed to women and the average loan size for our group loan product was \$324. As in years past, Esperanza offered its borrowers five different loan products, represented by 5,982 Bank of Esperanza loans, 113 housing loans, 691 individual loans, 26 water loans and 60 school loans. The loan portfolio averaged USD \$2.3 million during 2016 with the average loan disbursed in the amount of \$383.
