In 2018, Esperanza International, through Asociacion Esperanza Internacional, Inc., a religious organization in the Santo Domingo, provided 12,733 loans to deserving entrepreneurs in the Dominican Republic through its microfinance programs. Of those loans, 78.5% were disbursed to women and 55% were Haitian or of Haitian decent. As in years past, Esperanza offered its borrowers six different loan products, one more than in years past; 8,180 Bank of Esperanza loans, 3,419 Solidarity Group loans (the new product), 60 housing loans, 1,031 individual loans, 7 church initiative loans, and 36 school loans. The loan portfolio averaged USD \$2.6 million during 2018 with an average group loan disbursed in the amount of \$323, and the average individual loan of \$778.
