In 2017, Esperanza International provided 11,909 loans to deserving entrepreneurs in the Dominican Republic through its microfinance programs. Of those loans, 84% were disbursed to women and 47% were Haitian or of Haitian decent. As in years past, Esperanza offered its borrowers five different loan products; 11,056 Bank of Esperanza loans, 56 housing loans, 743 individual loans, 20 church initiative loans, and 34 school loans. The loan portfolio averaged USD \$2.3 million during 2017 with an average group loan disbursed in the amount of \$313, and the average individual loan of \$761.
