4a (Code: ) (Expenses \$ 433,997. including grants of \$ 205,958. ) (Revenue \$ ) In 2020, Esperanza International, through Association Esperanza International, Inc., a religious organization in Dominican Republic, provided 5,432 loans to deserving entrepreneurs through its microfinance programs. Of those loans, 77% were disbursed to women and 53% were Haitian or of Haitian descent. Esperanza offered its borrowers six different loan products: Bank of Esperanza loans, Solidarity Group loans, housing loans, individual loans, church initiative loans, and school loans. The loan portfolio averaged USD \$2.2 million during 2020 with an average group loan disbursed in the amount of \$288, and the average individual loan of \$945.
